- 147/24 Apologies for absence – Cllr Neil Gordon, Cllr Sharron Law, Colchester City Cllr Carl Powling, Colchester City Cllr Robert Davidson and Essex County Cllr Kevin Bentley
- 148/24 To record declarations of interest – Cllr Martin declared an interest in planning application 242122, as this refers to his own property.
- 149/24 Public Questions – a member of the public commented against planning application no 242347.
- Hannah Coyle the school head requested use of Church Green for the pupils to carry out orienteering activities. This will allow the pupils to hunt for moveable items using a map, to help them improve their skills. The Council agreed to allow this. Hannah also mentioned that several school staff now regularly park in the village hall car park, although this time of year they find it too dark to walk back and forth on the unlit roads. Traffic wardens have also been in the school area and issued tickets. Now the John Brunning pathway is better, the parents and pupils will be starting a walking bus from Rowhedge soon.
- 150/24 To receive reports from Colchester City Councillors - Dr Martin Parsons advised the NPF (National Policy Framework) may change at the end of December 2024. A White Paper will be published mid-December about the local government reorganisation.
